To all to whom these presents shall come greeting.
Where as there has been deposited in the General Land Office
of the United States a Certificate from Lewis Timothy Prince
hundred and thirty seven of the Register and Recorder at Oregon
City Oregon. whereby it appears that under the provisions of the
Act of Congress approved the 27th day of September 1850 entitled
An Act to create the office of Surveyor General of the Public
Lands in Oregon and to provide for the Survey and to make
donations to settlers of the said Public Lands, and the legisla-
tion supplemental thereto the claim of Stephen & Gager and his
wife Emily J. Gager of Lane County, Oregon Notification No 7028
has been established to a donation of one half section or there

beginning and ending across of land and that the same
 has been surveyed and designated as being in number forty, five
 being part of Section thirty three and thirty four in Township
 one north south of Range two West and claim number sixty
 and being part of sections three and four in Township eight
 south of Range two West according to the official Plat of Survey
